EDUCATION COMMITTEE REPORT by Russ Jackson

For those of us who "enjoyed the 60's and 70's, I am reminded of the line from "Pippen". "We've got magic to do" when it comes to the training at the 2011 convention. The training plan would not have been possible without the hard work of Charles Norton, Charlie McDaniel and Lori Ringo, with strong oversight from Tressa Bullard.

In this article I will discuss the events requiring the most time.

Monday – National Flood Inspection Program (NFIP). H2O partners will conduct this training as they did last year. For those of you who have not attended NFIP training in awhile, this is a must attend class. One, because you need the certification to work flood files and two because it is a great presentation; an eight hour class that feels like four.

Tuesday – USAA Certification. This is the first time a national carrier has agreed to conduct exclusive certification for NACA. An adjuster must have at least three years experience, be willing to take a drug test and have a background check. Once certified, the adjuster can work for any vendor representing USAA. Although the USAA presentation and testing is in the afternoon it is strongly recommended that those seeking certification attend the morning training. The USAA test is Xactimate intensive.

MENTORING TIP

A couple of weeks ago I spoke with a person that is trying to get into the adjusting business. He had been discussing the pros and cons with me of different training aspects, certifications and such. He made a comment that he was not certain mentoring was right for him. He suggested that in the past he had been successful in diving into problems and solving them for himself. While I applaud that type of mindset and determination, I also explained to him that while beating our head against a wall is entertaining for those around us, it is not always the best way to learn and grow.

I also spoke with a person that I had mentored for the last 3-4 years. I mentioned the comment to him and he was amazed that anyone would choose to fight and struggle with learning this business from scratch, when the mentoring program could open the door to a successful adjusting career. He told me that if he had walked into his first storm and not had a clue what to do or how to even route claims, he felt he would have severely hurt himself in the eyes of the vendor and other adjusters. He told me his confidence level was very low until he had helped me with 100 claims. He still struggled when he struck out on his own, but he had the basic knowledge and tools from the mentor program and was able to work his way through the ups and downs of his first storm. I now count him as one of the success stories of the mentoring program.

As a newbie, the experience is invaluable. The opportunity to have an experienced adjuster show you the basics, show you what makes them successful and guide you through the initial claims process gives you a road map to follow in the future. The first 100 claims a new adjuster is exposed to is overwhelming. Having a calm and experienced person show you how to set them up, scope them and control the closing work flow is well worth the time and effort. That training in itself can be the difference between adjusting success and failure.

Being a part of a mentoring program is a growth experience, both for the newbie and the mentor. As a mentor, we are training someone and that in itself keeps us on our toes and reminds us that we need to be at our best while we are in the field. We are working with someone that has limited experience and is looking to us for guidance and a proper model to be successful. It is a lot of work, but it is also very rewarding.

DID YA' KNOW

There is an iPhone app with a pitch gage -- It is GeoEstimator. I don't use their service but the pitch gage is handy and it is free, just download their app.

Having trouble opening Office 2007 files? This will help you to resolve the compatibility issues between the Office 2003 and Office 2007. A11 programs in Office 2003 used the old file extensions for its different programs. For example Word 2003 saved files with extension .doc, Excel 2003 with .xls and PowerPoint with .ppt. but on the other office 2007 used the new file extensions for its different programs. For example Word 2007 saved files with extension .docx, Excel 2007 with .xlsx and PowerPoint with .pptx. Now the problem is that when you will try to open Office 2007 files into Office 2003 and you will not open the file due to compatibility issues between both office versions. Microsoft provides a free compatibility pack to convert Office 2007 documents to the Office 2003 format. There are many third party free converter are available but here we are using Microsoft office compatibility pack.

Follow the given steps to download free Microsoft compatibility pack and install it. To use this feature, you will need to be logged into your computer with administrative rights.
